Results and Discussion

Based on observations and interviews, it was found that the formation of discipline character is not only the responsibility of the community and family environment, but the school environment also plays a crucial role in shaping discipline. Character is formed from three interconnected components: moral knowledge, moral feelings, and moral behavior. The implementation of religious activities at school aims to strengthen and develop specific character values, which then manifest in students' behavior, both during school and after graduation. Teachers are not only instructors but also facilitators who help instill good discipline and responsibility in students. Therefore, teachers' roles in this educational process are crucial to the success of character formation at school and make them the key guides who interact directly with the students.

3. Active Role of Parents and Family Environment

The formation of discipline and responsibility does not only occur in the school environment, but the family environment is also very important. If the patterns emphasized by parents are positive, a strong character will be formed in the students.

4. Awareness of Students

An essential supporting factor is the awareness that arises within the students themselves. The awareness that participating in religious activities at school, such as BTQ extracurricular activities, is crucial for developing an understanding of the Qur'an.

Several hindering factors for students in participating in BTQ extracurricular activities are:

1. Lack of Facilities

In terms of school facilities, there are still some that are insufficient for learning or activities, such as blackboards, projectors, and the prayer room used for BTQ activities, which are still inadequate.

2. Family Factors

The family plays a critical role in a child's development. The family is the primary center for character formation, and parents cannot blame the school for character education. If parents do not monitor and teach discipline and responsibility at home, it will be difficult to implement what is taught at school.

Analysis of Solutions to Overcome Hindrances in Strengthening Discipline and Responsibility Character Education at SMP Negeri 1 Candimulyo

In strengthening discipline and responsibility character in BTQ extracurricular activities at SMP Negeri 1 Candimulyo, several solutions have been proposed to address the challenges, based on data gathered from interviews, observations, and documentation, as follows:

1. Solution to Address the Lack of Facilities

and teachers. Facilities such as a prayer room are essential for facilitating BTQ extracurricular activities. Additionally, providing comfortable carpets and well-maintained prayer mats is important for Quran recitation activities. Regular maintenance of facilities is also emphasized. The cleanliness of the prayer room, classrooms, and educational equipment such as blackboards, LCDs, and projectors should be maintained properly. By maintaining cleanliness and properly caring for the facilities, students will learn the values of cleanliness and responsibility, which are integral to character education.

This shows the school's awareness of the connection between BTQ extracurricular activities and character education. By providing adequate facilities and maintaining cleanliness, it is expected that students can develop good character through consistent religious activities. The role of the school in providing and managing the necessary facilities is clearly reflected in the data. Overall, the solution indicates that school support in providing adequate facilities for religious education is essential. Regular maintenance and cleanliness are also vital factors in creating a good learning environment that supports students' character development.

2. Solution to Overcome the Lack of Parental and Family Support

Parental support is the most important element in the learning and habituation process for students, especially teenagers.
